## Electric Vehicle

We had a discussion in the newsletter some time ago about electric vehicles. My next door neighbour has just taken delivery of a brand new Tesla. I have booked my demonstration run, but am still waiting.

Pat and I went to NT Dyrham Park this Sunday. Those that know the place will remember that between the car park and the house is a steep and winding downhill access road. We walked down but decided to get the shuttle bus back up. They have two new electric vehicles that undertake the task admirably. In fact the situation is ideal for electric vehicles.

I spoke to the driver about regenerative braking. He confirmed that they had this feature, but said that on the first run of the day, it didn't work and he had to use the conventional brakes. He couldn't understand why this was? Thinking about it afterwards, it is obviously because the battery will be full after an overnight charge and therefore can't take any more electricity. After the first run dissipates the battery slightly, the feature is again available.

Because the battery is charged on every downhill run, he said that after a full day's use, without mains charging, the battery was still 76% charged.



## A Change in the Law



The GB sticker is no longer legal when travelling abroad or Northern Ireland.

The UK sticker is now required consequent to UK government changes in the law.

'Six Fighting Sons' -  
The Pickard's of  
Wingfield during the  
Great War.  
Researched by Tom  
Strickland  
August 2021

It was a cool summers evening at a Wessex MG club night just after lockdown 2021 that Terry and Sue Warder passed me a brown envelope and explained that I might be interested in the contents. **The title photo shows the content of the envelope.**

Well, I was amazed at the story that emerged...

In 1914 Job and Mary Pickard lived at Vine Cottage in Wingfield near Trowbridge. Job worked on the estate of Wingfield House for Sir Vincent Caillard. Together they had a large family of at least 11 children. Six of the boys served in the British forces during the war:

- Will was in the Wiltshire Yeomanry and survived the war
- Herbert was in the Royal Navy and served with Drake Battalion at Gallipoli (worth looking up what they got up to!) Herbert was wounded and discharged in 1916.
- James was with the Royal Flying Corps and also survived the war.

But the envelope said nothing of these three brothers

Instead, the envelope concentrated on just three brothers who went off to war together. The Postcards were mostly from Phil and the letters were about Joe and Tom. I slowly pieced the story together and then found that Richard Broadhead had a Newspaper article on them along with their photos in his large database to complete the story. Here is their story.

Phil, Tom and Joe all served together in A Company 1<sup>st</sup>/4<sup>th</sup> Battalion of the Wiltshire Regiment. The Regiment was sent to India as part of the Empire's defence against possible invasion or uprising. This was a very real threat with the Turks under German



leadership trying to invade through from the Middle East and also Germany was also financing and recruiting 'troublemakers' from Indian PoW camps to go back to India and stir up anti-British acts. The Regiment spent days on long 'Flag marches' and had an interesting time seeing many of the famous sites of India. The Postcards show pictures of the Red Fort and famous sites in Delhi but

also Hill top places such as Chakarata and Dehra Dun. Most of the postcards talk about sites the boys are seeing or culturally interesting things about India. The three young lads must have been having quite an eye-opening experience in stark contrast to their Wiltshire life experience so far. Before joining up Joe worked at the Palmer and Mackay Cloth Mill (Courts Mill?) in Trowbridge and that he joined the Territorials just


before the war. Tom worked at S. Collier and Co. Woollen Merchants and joined up when he heard Lord Kitchener's call to arms. Tom was also a chorister. Both boys played football and cricket for Wingfield and sometimes helped playing for Bradford club. Phil's story is not documented unfortunately.



At some point whilst in India Phil spent a Christmas in Hospital as there is a postcard where Phil points out where he was staying in the Sexan Hospital, Meerutt. I wonder how the boys felt being away from the real war and doing continuous long marches. A Concert troop was put together for the battalion's entertainment called the Moonrakers, so I expect that fun was had even if they were a little frustrated. The boys' turn was to come though and

in September 1917 the Regiment was moved to Palestine. General Allenby had taken over command of the Egyptian Expeditionary Force and prepared to go on the offensive

against the Turks and their German Officers in Palestine. Allenby had put together a well thought out plan that started with the surprise attack at Gaza. The attack started on the 31<sup>st</sup> October 1917. It was a great success and by Christmas Allenby

had taken Jerusalem, capturing 12,000 Turkish Prisoners of War. Unfortunately, not all the brothers were to survive the campaign. In November the Wiltshires were involved in the push on Gaza. At 2am on the 2<sup>nd</sup> November 1917 the Gurkhas to the left of the Wiltshires raided the Turks at Outpost Hill, this brought down retaliatory artillery fire on the Wiltshires. We are told what happened through two letters home to their parents. Joe's Platoon Officer Lieutenant Sainsbury wrote from 'the field' and explained that Joe was killed by a shell whilst sleeping in his 'narrow trench' and could 'have suffered no pain', I hope that this was true but we must acknowledge that nearly all letters home looked to alleviate the family's pain by saying

things like 'died instantaneously'. A later letter from the Company Commander, Captain Pye-Smyth, arrived a month later from his hospital bed in Cairo where we find out that Joe's burial was attended by Tom and that he was buried in a cemetery just to the 'rear of the lines'. A few days later, on the 7<sup>th</sup> November The Wiltshires



were ordered to move forward and take Fryers Hill just east of Gaza. They were shelled by the Turks the whole way that they advanced, suffering 8 deaths and 73 wounded, one of those killed was Tom. Captain Pye-Smyth's letter explained that Tom was killed on Fryers Hill in the afternoon and was buried there on the hill itself. One gets the feeling that the

Wiltshires had it really tough in this battle! Pye-Smyth also talks of Phil and says he was 'stunned' about Tom's death and went to double check that it was true. He expresses that he was glad that Phil was 'spared the stress attending the two battles of El

Mesmiyeh on the 13<sup>th</sup> as he was given the job of collecting reinforcements (Was Phil deliberately sent to spare the loss of another brother?).

Later, the local community found out through the casualty rolls published in the papers and so the family received letters, including one from the local Bishop. A friend of Joe writes that she had been in constant letter contact and asks for a photo of him. Once the news got out at home the local paper ran a story

about the 'Six Fighting Sons' and this sparked the family to receive some more supportive letters. Phil fortunately survived to live in Upper Studley, Trowbridge, but he must have always been scarred by the loss of his two brothers.

Tom and Joe are now buried in the same plot, a few graves apart, in the CWGC Cemetery in Gaza (Battlefield graves were often concentrated later into larger cemeteries post war)
